Having completed, at much careful labor and expense, the new hotel, and provided for its formal opening in charge of a family so well and so favorably known to you as to furnish the strongest assurance that it will be kept in a manner creditable to all concerned, it is now in readiness to be transferred to your care and keeping, and upon your favor it must hereafter chiefly depend for that degree of success which it shall attain. It is intended as an institution and monument to illustrate and exemplify the principles of temperance sobriety, and good order which for a long period of time have characterized the prevailing elements of society in this town, and as such it is anticipated the intelligence morality and virtue of the community will protect and sustain it.

Your neighbor who has had in charge the construction of this edifice, came to this place forty-seven years ago, and has participated in the many physical, moral and social changes which have transpired among you, and in some degree at least, co-operated with others in promoting every good work in the community. Whatever of success has attended his own personal efforts and business may be justly attributed to a good degree to the abiding confidence which the community have reposed in his integrity and honor, and to his own habits of temperance, frugality and preserving industry.

He takes pleasure in referring to the fact that Walworth was the first town in the State which refused to grant a license to sell intoxicating liquor, and has had none since (now about 40 years), and it is gratifying to be recognized as one among the many who have persistently adhered to the right, pending all the struggles which have attended the triumphs of the temperance cause among us.

Therefore, realizing the necessity for a good hotel in our village, which in most respects is conceded to be one of the pleasantest in the State, and recognizing the interest the people take in beautifying their homes as well as in promoting their general welfare, peace and good order of the community by sustaining so thoroughly the \_\_\_\_\_ of temperance and appreciating with enduring recollections and thankfulness the many and long manifestations of their confidence, he feels a pleasure in making sure of so much of the exertion of his will through his own personal efforts as is shown in the erection of this hotel and the improvement of its surroundings. It now remains for our citizens, and especially the friends of temperance, to say by their actions whether this shall be a failure or a monument of pride and honor to the whole town by so sustaining it as to make it known as one of the best hotels: all interests, pecuniary, social, moral and religious should so operate in sustaining it, and they in turn will receive reciprocal benefits. That it will be sustained is confidently anticipated.

A Rochester Man Commits Suicide

... A man from Rochester by the name of William Johnson ... removed to Palmyra. From there he went to Walworth where he has since resided for the last two or three months. He is said to have been drinking hard and it is thought some serious trouble was preying on his mind. He went to the <u>Pacific hotel</u> and swallowed a heavy dose of arsenic which caused his death Wednesday evening. The deceased was a painter and grainer by trade and was much thought of by all who knew him. He was industrious and skillful as a workman and had a host of friends who deeply regret his unfortunate end.

The Lake Shore News May 22 1879 p.2 (N)

The Palmyra Journal of the 8<sup>th</sup> gives the following account: "William Johnson, a painter by trade, suicided last night by, it is supposed arsenical poisoning. Johnson was a man addicted to the intemperate use of liquor, and was just recovering from a debouche. On Tuesday evening he went to Walworth from Palmyra on the stage but was not then in liquor. He retired to his room at the <u>Pacific Hotel</u> yesterday afternoon and went to bed. This morning as he did not make his appearance, his room was entered, and Johnson was found undressed and abed, dead and cold, a bottle of arsenic stood upon a stand near the bed and a pitcher near him bore evidence of having been used as a drinking vessel. He was a man 66 years old, a clever intelligent fellow and one of the very best mechanics in his line."

The oyster supper at the <u>Pacific Hotel</u> Walworth was a grand success financially and socially. Walworth has a live landlord.

The Lyons Republican is in error in saying that there was never a <u>liquor license</u> granted in the town of Walworth since it "has been a town, which is now about forty years." There have been liquor licenses in Walworth and the town has been organized considerably longer than 40 years. – Lyons Press

William Ryan, has for several years roomed at the <u>Pacific hotel</u> in Walworth and worked for various people about town. He had complained of distress across the chest for a day or 2 and being missed from the house, search was made and he was found in an out-house dead. It supposed that death was caused by heart disease.

Palmyra NY Courier Saturday Nov 29 1884 (F)

Mr. Wm. Byron, an employee of Mr. Yeomans, was found dead in the water closet of the Pacific Hotel last evening. He had been ill during the day and complained of a pain through his chest. It gave a severe freight to the maid who found him.

The first of a series of social projects by the Ladies Aid Society of the M. E Church of Walworth for this winter was held at the <u>Pacific hotel</u> on Tuesday evening.

The Palmyra Courier July 17 **1885** p.2 (N)

The <u>Pacific Hotel</u> at Walworth is very popular with the politicians. Almost every day 3 or 4 ambitious candidates are registered at this well-known hostelry, and discussing the affairs of the nation in one or more of the parlors of the house. It has even been reported that a certain Senator had taken up permanent quarters there but we think the report lacks confirmation.

The church social at the <u>Pacific hotel</u> in Walworth was a success, though the roads were bad and the weather unpleasant. The singing by Messrs. Billings, Clark and Pound was highly entertaining and the bountiful repast donated by the ladies of Walworth under the direction of Mrs. Sanford was practically tested and pronounced first class.

Mr. L. Freeman has assumed control of the <u>Pacific Hotel</u> at Walworth. Mr. Sanford, the late proprietor has gone into the mercantile business at Ontario.

James G. Camp Passed Away Tuesday

Enlisted in the Civil War When Fifteen Years Old – Wounded at Gettysburg – Death in the Village –

The death of James G. Camp Tuesday morning came as a shock to a great many although it had been known for some time that he was having serious trouble with his heart besides being a sufferer from Bright's disease. Mr. Camp was born in east Bloomfield where his boyhood was spent until he enlisted in the Civil War, Regiment No. 126 when but 15 years old. He was wounded at Gettysburg by a gunshot which tore away the fleshy part of his left thigh. Gangrene developed and he was in a hospital for a long time. His thigh had always caused him much pain and trouble. He returned after three years' service and was married March 11 1921 to Helen Reeve of Victor, in which vicinity they lived for several years. The death of his only children, a son and daughter, who had grown to manhood and womanhood, was a great blow which molded his life, although he was of a cheerful disposition and always ready to speak a pleasant word to all. He moved to Walworth several years ago and conducted the stage route for many years. He was proprietor of the Pacific Hotel for a number of years and was widely known. After leaving the hotel about two years ago, he purchased the Julian Findley house where he lived at the time of his death. He was 58 years old the 21st of July. He leaves a wife and one grandson, Drewry? Sawyer of Rochester. The funeral was held from his home Thursday at 2 o'clock, Rev W. O. Peet officiating. Burial in Walworth cemetery.

Last Veteran of Civil War in Marion Passes

Marion Feb 25 – Funeral services for Madison Reynolds, last of the Civil War veterans of this town were held from the home in Buffalo Street yesterday afternoon. The burial in Marion Cemetery was conducted by the American legion of Palmyra. Mr. Reynolds was born in the town of Sardinia on June 5 1837. His first vote was cast in 1860 for Abraham Lincoln. He enlisted in 1862 in Company F., 116 New York Volunteers and served until 1863 when he was honorably discharged in Elmira. On Dec 13 1864 he married Sophia Carman who survives him. They have lived in Marion village since 1891 coming from Walworth where they conducted the Pacific Hotel. Besides his widow he is survived by four daughters, 16 grandchildren and 11 great-grandchildren. The daughters surviving are Mrs. DeWitt Tuttle of Walworth, Mrs. Albert Garlock of Marion, Mrs. Salem White of Syracuse, and Mrs. Arthur Bates of Rochester. Mr. Reynolds was the last member of John B. Burrud Post G.A.R.

The second floor serves as our Hall, dining room and kitchen, while on the lower floor are housed a feed store, post office, barber shop and an apartment.

The family lived on the Whitbeck Farm near Sodus, later moving to Walworth. On Feb 19 1880, he married Miss Lucina VanZandt. For several years, he was proprietor of the Pacific Hotel at Walworth, leaving that to come to Marion 12 years ago.
